# **New Hartford Central School District residents** to vote on 2024-25 budget on May 21

On Tuesday, May 21, New Hartford Central School District residents will vote on a \$64,443,792 proposed budget for the 2024-25 school year. The proposal carries a 2.24% percent tax levy increase and represents a spending increase of \$1,625,429.

Voters will also elect two candidates who will each serve five-year terms on the board of education and decide on a \$671,016 school bus purchasing proposition (see page 5).

The proposed budget maintains all current student programs, learning opportunities for both students and staff, support for students' social, emotional and mental health, and the district's educational technology.

Each year, district officials work to provide a spending plan that supports the district's vision and provides for the needs of all students while maintaining the fiscal responsibility owed to the community at large. The proposal aligns with the district's four priority areas outlined in the district's 2023-28 strategic plan: academics, communication and collaboration, facilities, and school environment and connections.

#### District facing smaller state aid increase

The district's primary revenue sources are state aid, the tax levy and payments in lieu of taxes, which account for approximately 97% of the budget revenues.

Although the district is expected to receive approximately \$317,000 more in state aid, including BOCES, transportation, building and special education aid for next year, this increase is significantly lower than the \$4.3 million budgeted increase for 2023-24.

"Careful and thoughtful financial planning has afforded us the opportunity to continue providing exceptional educational programs, despite a smaller state aid increase," said Superintendent of Schools Dr. Cosimo Tangorra Jr. "During a time when many districts are dealing with their own budgetary crisis, cutting programming and staff, we are pleased to preserve our robust programming and services, which directly benefits students."

#### Academics remain a top priority in the proposed budget

The proposed budget will sustain traditional class sizes to promote quality instruction and will continue to support athletic and extracurricular activities, as well as participation with regional summer school for grades 7-12.

To assist in meeting the individual needs of students with targeted interventions, the budget proposal maintains literacy and mathematics assessments for grades K-8. Basic early literacy skills programs will also continue to be implemented in grades K-3.

BOCES programming, including School and Business Alliance, Regional Program for Excellence, Career and Technical Education, Modules of Integrated Technologies, and Pathways in Technology Early College High School will continue to be supported as the district focuses on individualized student success and offering multiple pathways to graduation.

Participation in additional BOCES services to support students with special needs, safety, and student support and bullying prevention programs will be maintained.

In addition, the spending plan includes resources to support and enhance curriculum to ensure classroom instruction meets the needs of all students, remains innovative and relevant, and aligns with best practices.

Integrated technology instructional support will also be maintained under the proposed spending plan.

#### **Budget plan supports positive school** environment and connections

The budget proposal maintains the district's partnership with Connected Community Schools at the elementary level, which provides students with resources, services and programming to ensure their basic needs are met. This allows students to focus on and enjoy learning in order to succeed academically, socially and emotionally.

The district's character education programs, along with social, emotional and mental health services for students, will also be maintained.

In an effort to ensure the safety and security of students, staff and visitors, the budget proposal will maintain the district's school safety officer contract with the Town of New Hartford.

#### Spending proposal continues commitment to communication and collaboration

The district contracts with Capital Region BOCES and OHM BOCES for communications service, which provides communications support to the district for its internal and external messaging. The budget proposal will sustain this service to facilitate transparency and good-will between the district and its stakeholders.

The budget proposal will also continue to fund the district's primary communication platform, ParentSquare. ParentSquare allows families, staff and community members to receive district communication via email, text or app notification. #### Proposed budget maintains focus on facilities and technology


The budget includes funding to provide and maintain the distribution of a Chromebook to

every K-12 student to promote a future-focused learning environment. The investment supports the district's long-range plan to implement advancements in technology.

The district will continue to participate in regional contracts for the purchase of energy supplies, which have provided a savings of several hundred thousand dollars to the district over the past several years.

A \$100,000 capital outlay project, for sidewalk and miscellaneous door replacement, is planned to begin at the high school during the 2024-25 school year.

#### **Voter Qualifications**

You must be registered to vote in school elections. Voters registered to vote with the Oneida County or Herkimer County Board of Elections who are residents of the district will be allowed to vote in the New Hartford school elections without registering. To qualify to vote you must be:

- 18 years of age or older
- A United States citizen
- Registered to vote
- A resident of New Hartford Central School District for 30 days or more


#### **Absentee Ballots**

It is possible to vote by absentee ballot. Forms to request absentee ballots should be requested by mail from the District Clerk, Kim Schweitzer, c/o District Office, 33 Oxford Road, New Hartford, New York 13413. Completed applications for absentee ballots must be received by the District Clerk at least seven days before the election if the ballot is to be mailed to the voter, or the day before the election if the ballot is to be picked up by the voter. The completed ballot must be received by 5 p.m. on the day of the vote.

#### **Early Mail Voting**

The new Early Mail Voter Act, effective Jan. 1, 2024, allows for early voting via mail without being required to have a reason. Individuals who wish to vote early by mail must submit an application. Requests for an application should be mailed to the District Clerk, Kim Schweitzer, c/o District Office, 33 Oxford Road, New Hartford, New York 13413. Completed applications for early mail voting must be received by the District Clerk at least seven days before the election if the ballot is to be mailed to the voter, or the day before the election if the ballot is to be picked up by the voter. The completed ballot must be received by 5 p.m. on the day of the vote.

# District defines student skill set to ensure 21st century success

The New Hartford Central School District is defining what it means to be a New Hartford student and a lifelong learner. The district developed its Portrait of a Spartan, a collective vision that articulates the district's and community's aspirations for every student in the district. It provides strategic direction for the overall educational experience of students and includes a defined set of skills and competencies that students should possess upon graduation in order to achieve success.

# Portrait of a Spartan is comprised of six competencies:

- Adaptability Creative, curious, entrepreneurial thinkers who exhibit flexibility and a growth mindset
- > Empathy Show kindness while understanding and respecting the feelings and perspectives of others
- Communication Articulate thoughts and ideas effectively using oral, written, and nonverbal communication skills for authentic purposes
- Critical thinking Challenge themselves to think differently and identify, evaluate, and prioritize solutions to complex situations
- Integrity Take responsibility, honor their commitments, and are accountable for their actions
- Global citizenship Value and embrace diverse cultures and personally engage in civic, social, and global action

"Now more than ever, our learning experiences must continue to not only provide for the acquisition of rigorous academic content, but must also be intentional about fostering the 21st century skills our students need to thrive," said Superintendent of Schools Dr. Cosimo Tangorra Jr. "Our Portrait of a Spartan is locally developed, but globally positioned so students in kindergarten through grade 12 can be successful in a world that is changing faster than ever."

The development process began in October 2023. A Portrait Design Team, consisting of school and district leaders, board members, educators, students, families and community members, attended four collaborative work sessions to identify and define each competency, and discuss implementation.

As next steps, district administrators will create an actionable plan to put Portrait of a Spartan into practice. This will include providing professional learning opportunities for district educators to ensure each competency is attainable for every student through authentic learning experiences.

The administration will evaluate and revise the district's Portrait of a Spartan implementation plan several times annually to maintain relevancy and alignment with the district's vision, mission, goals and strategic plan.



# School Tax Relief (STAR) Eligibility

Under state law, all residential property owners, regardless of age, may receive a \$30,000 property tax exemption from the full value of their property, provided they filed for the exemption with their town assessor or at www.tax.ny.gov/star.

# Basic STAR Exemption: A reduction on your school tax bill

- If you have been receiving the STAR exemption since 2015, you can continue to receive it for the same primary residence. As long as you remain eligible, you'll see a reduction on your school tax bill for the amount of your STAR exemption. NOTE: The STAR exemption is no longer available to new homebuyers.
- Available for owner-occupied, primary residences where the resident owners' and their spouses' incomes are less than \$250,000.
- Based on the first \$30,000 of the full value of a property, provided that they filed for the exemption with their town assessor or with New York State at www.tax.ny.gov/star.

#### **Basic STAR Credit Check:**

- If you are registered for the STAR credit, the Tax Department will send you a STAR check in the mail each year. You can use the check to pay your school taxes. You can receive the STAR credit if you own your home and it's your primary residence and the combined income of the owner and the owner's spouse is \$500,000 or less.
- Based on the first \$30,000 of the full value of a property, provided they filed for the exemption with New York State at www.tax.ny.gov/star.

#### **Filing for Basic STAR**

- If you have filed for the Basic STAR (no age criteria), it is not necessary to reapply each year.
- If you have not previously applied, you must apply at the appropriate town assessor's office or with New York State.

# District earns state-wide school safety recognition award

For the 12th consecutive year, the New Hartford Central School District has earned Utica National Insurance Group's top safety award for its efforts to keep students, staff and visitors

safe. The district received the Utica National Insurance Group's "School Safety Excellence Award" for 2024 at the Titanium with Honors level.

The award program has three levels — titanium, platinum and gold — in which schools can earn a meritorious distinction by meeting specific criteria to enhance overall safety. Categories covered include bullying prevention programs, playground safety and other areas, measured using specific quantifiable surveys. At Utica National's 42nd school safety seminar, district administration accepted a certificate to commemorate the district's

safety efforts and a \$500 award, which will be used for school safety initiatives.

New Hartford Central School District is one of at least 160 school districts and Board of Cooperative Educational Services (BOCES) in New York State to receive the award.

#### **Filing for Enhanced STAR Exemption**

- All Enhanced STAR recipients are required to participate in the Enhanced STAR Income Verification Program (IVP). In the first year that you apply for the Enhanced STAR exemption, your assessor will verify your eligibility based on the income information you provide. In the following years, NYS will verify your income eligibility. You will not need to reapply for the exemption or provide copies of your tax returns to your local assessor.
- Provides an increased benefit for the primary residences of senior citizens (age 65 and older) with qualifying incomes (\$98,700 or less for the 2024-25 school year.)
- ➤ Based on the first \$84,000 of the full value of a home for the 2024-25 school year.

#### **Senior Citizen Exemption**

Seniors may also qualify for additional non-STAR Senior Citizen exemption. This exemption may entitle a homeowner to an exemption beyond the Enhanced STAR exemption.

#### Living Quarters for Senior Parent or Grandparent Exemption

> The Board grants an exemption from taxation to the extent of an increase in assessed value of residential property resulting from the construction or reconstruction of the property for the purposes of providing living quarters, as a primary residence, for a parent or grandparent, who is 62 years of age or older. This exemption is subject to certain limitations detailed in Section 469 of the Real Property Tax Law.

# Filing for Senior Citizen Exemption and Living Quarters Exemption

Tax exemption applications are processed through the appropriate town assessor's office and Senior Citizens exemptions are tied to age and income.

On May 21, New Hartford voters will elect two district residents to serve on the New Hartford Board of Education. The individuals elected will each serve a five-year term beginning July 1, 2024.

The board is comprised of seven school district residents, elected by voters, and is the official policy-making body of the school district. Board members are not financially compensated. Candidates are listed in the order they will appear on the ballot.

#### Andrew K. Ward

Andrew K. Ward is seeking his second term on the board of education. He and his wife, Jennifer, have three children: one who attends Perry Junior High



School and two who are graduates of New Hartford Senior High School. Mr. Ward has been a district resident for 27 years.

A Remsen Senior High School graduate, Mr. Ward received a Bachelor of Arts degree in economics from Union College and a Juris Doctor degree from University of Dayton School of Law. Mr. Ward is an attorney and owner of Ward Arcuri Foley & Dwyer Law Firm, where he specializes in estate planning legal work.

Mr. Ward is involved in the Perry Jr. High PTA and Upstate Caring Partners, previously serving as its Board of Directors President for five years. He is also a member of the Utica Zoo Board of Trustees and the ARC Guardianship Committee. # Voters to decide on bus replacement proposition



On Tuesday, May 21, voters will decide on a school bus purchasing proposition at a total cost not to exceed \$671,016. The proposal includes the purchase of two 66-passenger buses, one 37-passenger bus and one 30-passenger bus.

The proposed new bus purchases would replace a total of four buses; two 66-passenger buses, one 30-passenger bus, and one 28-passenger bus, each of which have an average of 11 years of service and 100,000 miles.

The state will reimburse the school up to 76 percent of the cost of the new vehicles. The district plans to sell/trade in four buses with an expected total trade-in value of \$15,000. The local share for the remainder of the cost would be approximately \$157,000.

The ideal replacement cycle for district buses is 10 years, when it is no longer cost effective to

make the repairs needed to

meet state inspection standards. Maintaining an aging school bus presents potential safety, maintenance and financial issues for the school district. After 10 to 12 years of service, bus maintenance costs increase by 10 to 20 percent and trade-in values decrease exponentially.

The district is required by the state to have enough buses to transport every student in the district in the event of an emergency, regardless of the number of students who walk or receive parent/guardian transportation to school. New Hartford buses transport approximately 2,500 students daily to 12 public, private and parochial schools, and travel 450,000 miles annually.

# Before- and after-school program offers students enrichment opportunities

Right at School offers families onsite childcare and student enrichment activities at each of the district's three elementary schools. The program includes more than 180 hands-on learning activities, homework support, games and sports, activities designed to support social-emotional learning, student-led community service projects, music and art.

On school days, the before-school program runs from 7 to 8:50 a.m. and the after-school program runs from 3 to 6 p.m.

Families can elect to participate in the morning and/or afternoon program for one, two, three, four or five days a week; pricing varies. A 10-day punch card is also available for purchase, providing families the option to have their student attend as needed. Families may qualify for discounts, including a sibling discount, and financial assistance.

Right at School has been the district's beforeand after-school program provider since the 2022-23 school year.

Students who will attend Bradley, Hughes or Myles elementary schools during the 2024-25 school year can now register for fall 2024 enrollment in the Right at School program.

Kim Strong is seeking her first term on the board of education. She and her husband, Mike, have one child who attends Hughes Elementary School. Mrs. Strong has




been a district resident for 15 years.
